As part of making a submission to 4 Sharp Corners LLC, 4 Sharp Corners LLC customers must read and affirmatively agree to the following Terms and Conditions in order to advance through and complete their order as part of the submission process. 4 Sharp Corners LLC customers agree to abide by this Agreement and further agree that 4 Sharp Corners LLC is entitled to rely upon and benefit from this Agreement, as part of the 4 Sharp Corners LLC submission process.

1. All terms and conditions are subject to change.
2. 4 Sharp Corners LLC will not consign items which bear evidence of trimming or any other form of tampering, or are of questionable authenticity, and customer agrees not to knowingly submit any such items. 4 Sharp Corners LLC reserves the right, at their sole discretion, to refuse to auction any item showing evidence of tampering or alteration. Customer agrees that in the event 4 Sharp Corners LLC rejects any items for consignment, 4 Sharp Corners LLC shall return the item at the expense of the consignor.
3. All items, including damaged items, not conforming to the Acceptable Submissions standards will be mailed back to the consignor at their own expense.
4. 4 Sharp Corners LLC shall have no liability whatsoever to the consignor for items that are damaged while not in custody or control of 4 Sharp Corners LLC.
5. 4 Sharp Corners LLC will exercise reasonable care in handling items submitted for consignment. However, if 4 Sharp Corners LLC determines that customer's item was lost or damaged while in 4 Sharp Corners LLC's possession, customer will be compensated based upon the fair market value of the item as determined by 4 Sharp Corners LLC, which may include filing a claim with our insurance carrier. The declared value the consignor provides with this submission is for estimating the insurance coverage only, and the fair market value of the item may be less than the declared value.
6. If any items are being submitted for a third party, customer represents and warrants that such third party has agreed and accepted this Agreement and has signed a duplicate copy hereof. Customer agrees to provide that third party signed copy to 4 Sharp Corners LLC at any time upon its request.
7. Have an item that deserves special marketing? Let us know! We encourage our consignors to inform us when they submit high-valued items. Simply note on your submission form if you have an item(s) with auction value of \$1,000 or greater and we will prioritize such items.
8. 4 Sharp Corners LLC will take ownership of all items that complete their auction with zero bids.
